

## FIVE YEAR PLEASURE CRAFT LIMITED WARRANTY

Subject to the limitations and conditions as set forth herein, Phasor Marine ("Manufacturer") warrants to the first retail purchaser of any of its Phasor Marine Generator Sets or Marine Propulsion Units installed in Marine Pleasure Craft ("Equipment") that the Equipment is free from such defects in material and workmanship as may appear under normal use during the applicable warranty time period. Manufacturer further warrants to the first retail purchaser that under normal conditions the Equipment will supply the output as designated in the written specifications which accompany the Equipment.

The time period for the coverage afforded through this warranty commences as of the date of the delivery of the Equipment to the first retail

- Up to two years or 2,000 hours, whichever first occurs, for all parts and labor.
- Up to five years or 4,000 hours, whichever first occurs, for parts and labor limited to only the following components: crankshaft, pistons, connecting rods, valve lifters, cylinder block, valves, cylinder head, generator rotor and generator stator.

## WARRANTY CONDITIONS: The conditions attendant to this warranty are as follows:

- 1. All claims must be pre-approved in writing by an authorized representative of the Manufacturer prior to any repair work being performed.
- 2. Manufacturer, at its option, shall have the right to repair or replace all defective and/or non-conforming parts or components.
- Written notice of all claims must be mailed to the Manufacturer within 30 days of the repair at its address, which notice must include: The name and address of the owner, proof of the date of purchase of the Equipment, the Equipment serial number and pertinent information
- 4. Travel to perform warranty work is limited to 2 1/2 hours and 100 miles (round trip).
- 5. Removal and reinstallation of below deck generator sets, maximum 4 hours.
- 6. Removal and reinstallation of above deck generator sets, maximum 1 hour.

## WARRANTY LIMITATIONS: This warranty shall not apply to any one or more of the following:

- 1. Any repair or replacement attendant to normal maintenance, including but not limited to, replacement of oil, fuel and oil filters, engine fluids,
- 2. Any repair or replacement caused, in whole or in part, by: accident, collision, misuse, neglect, unauthorized or improper installation, repairs or alterations, lack of proper maintenance, acts of God, or use of other than Manufacturer's recommended parts.
- 3. Any repair or replacement resulting from the use of auxiliary starting aids or greater than a 50/50 solution of ethylene/glycol based antifreeze
- 4. Any repair or replacement resulting from water or airborne abrasives entering into the unit or the unit being immersed or sprayed with water.

THIS WARRANTY IS LIMITED TO REPAIR AND/OR REPLACEMENT OF THE EQUIPMENT. UNDER NO CIRCUMSTANCES DOES THE WARRANTY INCLUDE PAYMENT OR REIMBURSEMENT OF ANY INCIDENTAL OR CONSCOUENTIAL COSTS. EXPENSES, DAMAGES OR LIABILITY WHICH MAY BE ATTEMDANT TO ANY DEFECT OR FAILURE OF THE FOLIPMENT. THIS IS AN EXPRESS WARRANTY AND IS LIMITED TO THE TERMS. AND PROVISIONS HEREOF. THERE ARE NO OTHER WARRANTIES APPLICABLE TO THE EQUIPMENT, AND THE PERFORMANCE OF NEEDED REPAIRS OR REPLACEMENT OF DEFECTIVE PARTS IS THE EXCLUSIVE REMEDY AVAILABLE. ANY IMPLIED WARRANTIES INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE SHALL BE LIMITED IN DURATION TO THE TIME PERIOD SET FORTH ABOVE. Some states do not allow limitations on how long an implied warranty lasts or the exclusion or limitations of incidental or consequential damages. So the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may have other rights, which may vary, from state to state.

The purchaser/user is responsible for the regular inspection and maintenance of the Equipment and to keep the Equipment in a safe and operable condition, so as not to cause personal injury or put the operator and/or any other person in a life threatening situation. It is the responsibility of the owner to have parts repaired or replaced when continual use of the Equipment could cause damage or excessive wear which without repair may lead to premature

The purchaser of Manufacturer's Equipment assumes the responsibility to read the Operator's Manual(s) so as to understand the safe and correct operating procedures pertaining to the operation and to consider the possible limitations of the Equipment and to lubricate and maintain the Equipment
